## 4. First-aid Measures

### 4.1 Description of First Aid Measures

**GENERAL NOTES:** When symptoms persist or in all cases of doubt seek medical advice.

**AFTER INHALATION:** Move to fresh air. Consult a physician after significant exposure.

**AFTER SKIN CONTACT:** Use a mild soap if available. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes.

Heating or fire can release toxic gas.

### 5.3 Advice for firefighters

In the event of fire, wear self-contained breathing apparatus. ABC powder. High volume water jet. Hazardous decomposition products formed under fire conditions. Collect contaminated fire extinguishing water separately. This must not be discharged into drains. Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide. Danger! - water reactive substance.

### 7.1 Precautions for safe handling
